OFFICER TAKING REPORT: DAVIS, EVERETTE

CASE NARRATIVE

ON THIS DATE AT 0832 HOURS I WAS CALLED TO THE RESIDENCE AT 1900 CENTARK COVE FOR AN ATTEMPTED SUICIDE, SEE INCIDENT 2014-7048. WHILE AT THE SCENE I NOTICED A LARGE AMOUNT OF AMMO AND A .22 CALIBER RIFLE LEANED AGAINST THE BED IN THE BEDROOM WHERE THE ATTEMPTED SUICIDE HAD OCCURRED. WHILE TALKING TO INDIVIDUALS IN THE HOUSE IT WAS LEARNED THAT THE FEMALE THAT HAD SHOT HERSELF, AARON POWELL DOB [REDACTED] AND ANOTHER FEMALE, RACHEL WORKMAN DOB [REDACTED], WERE BOTH CONVICTED FELONS. I LOOKED ON THE TABLE NEXT TO THE BED AND SAW A RED BAG AND COULD SEE SOMETHING IN THE BAG. I DID NOT RECOGNIZE IT AS ANYTHING, BUT SERGEANT WAYNE BEAN RECOGNIZED IT AS MILITARY GRADE GRENADE SIMULATORS. AT THIS POINT I HAD EVERYONE EXIT THE ROOM AND CONTACTED ATF AGENT SHANNON MCCITTRICK-CRUSE WHEN AGENT MCCITTRICK-CRUSE ARRIVED I SHOWED HER AND EXPLAINED TO HER WHAT WE HAD. WE TYPED UP A SEARCH WARRANT FOR THE RESIDENCE AND CURTILAGE AND HAD IT SIGNED. AT 1438 HOURS WE EXECUTED THE SEARCH WARRANT AND FOUND GUNS (SOME OF WHICH WERE REPORTED STOLEN), DRUG PARAPHENALIA, AMMO, AND DRUGS (METH). MR. HEARINGTON HAD ALREADY BEEN PLACED INTO CUSTODY AT THE TIME OF THE SEARCH WARRANT FOR POSSESSING THE EXPLOSIVE DEVICES. MR. HEARINGTON WAS CHARGED WITH SIMULTANEOUS POSSESSION OF DRUGS AND FIREARMS, POSSESSION OF A CONTROLLED SUBSTANCE, THEFT BY RECEIVING, CRIMINAL USE OF PROHIBITED WEAPONS, FURNISHING A HANDGUN TO A FELON, AND POSSESSION OF A CONTROLLED SUBSTANCE.
