## CASE NARRATIVE

---

ON 6-17-2014 AT APPROXIMATELY 5:12 A.M., I WAS DISPATCHED TO 16925 EAST MILLER SAIRDIS IN REFERENCE TO A CRASH. WHILE ENROUTE CENTRAL DISPATCH ADVISED THAT THE COMPLAINANT BELIEVES THAT THE PERSON IS DEAD AND THAT HE IS COVERED WITH BLOOD. UPON MY ARRIVAL I MADE CONTACT WITH THE COMPLAINANT, LATER IDENTIFIED AS ABEL ENRIQUEZ, ENRIQUEZ ADVISED THAT HE WOKE UP TO A CRASH AND FOUND HIS FRIEND DEAD. I CHECKED ON THE VICTIM (ANTHONY BALLENTINE). I THEN NOTIFIED SGT. DUDDERAR, DET. HALL AND SALINE COUNTY CORONER CLEGHORN. THE SCENE WAS RELEASED TO THE DETECTIVES UPON THERE ARRIVAL.
